Notification of Results of Lead-based Paint Testing



Dear Resident:

The Department of Housing and Urban Development (HUD) requires Public Housing Authorities to test their housing units built before 1978 for the presence of lead-based paint and to notify residents of the results.

Lead-based paint testing was performed at the **Estrada Courts** Development and some positive results were found. This means that lead-based paint was found in a few places on the inside and outside of units. The places where lead-based paint tested positive are:

Inside

- **doors/windows & frames**
- **closet shelf supports**

Outside

- **doors, windows & frames**
- **clothes line supports**
- **support beams & parts (joists & headers)**
- **window & door rain protectors (drip caps)**
- **telephone boxes**
- **frame molding**
- **roof overhang structures (eaves & fascias)**
- **storage doors**
- **support columns**
- **porch area structures (eaves, fascias & rafters)**

A small sample of positive readings for lead-based paint was found inside:

- **wall protective railings (chair rails)**
- **exhaust fans**
- **steps (stair treads)**
- **floor moldings (baseboards)**
- **ceilings**
- **closet shelves**
- **vanity doors**

Chipping or cracking lead-based paint may be a health risk for your family. This is especially true if you are pregnant or you have children younger than seven living with you who may chew on chipped paint. If you see chipping or cracking paint, inform your management office immediately. There are further steps you can take to protect your family from lead poisoning. Keeping your home free from dust by cleaning with a damp cloth or mop and eating nutritious foods are some of the things you can do.

Some indications of lead poisoning include tiredness, vomiting, unwillingness to play or eat, concentration difficulties, head or stomachaches, jumpiness, crankiness or constipation. Your children may have lead poisoning, however, even if they don't seem sick. If you think lead poisoning is possible, get the person tested by a doctor right away. This test is covered by Medi-Cal. A nearby clinic that does blood lead testing is:

If you find out that anyone in your household has an elevated blood lead level, consult with a doctor about treatment and tell the Manager of your development immediately. You may also be eligible to receive a free health check-up for your children (including blood lead level-testing) from the **Child Health and Disability Prevention Program (CHDP)**.
